Membership Access

Prospective members must meet the Membership Criteria as set out in the document [SPEAQ Key Information](#).

Membership Structure

[Individual members](#)

Membership fee paid by an individual – provides full member privileges. This is for individual practitioners working directly with persons using DFV in QLD on the continuum of behaviour change intervention

[Organisational members](#)

Membership fee is paid by the organisation – nominated employee participants from that organisation have full member privileges. This is for organisations providing direct client service delivery to persons using violence in QLD on the continuum of behaviour change intervention.

[Associate Individual or Associate Organisational members](#)

Two categories of Associate membership exist – for Individuals and for Organisations not working directly with persons using DFV in QLD on the continuum of behaviour change intervention, but wanting to engage with and support the work of the network. Associate members do not have voting rights and cannot be a member of the SPEAQ Steering Committee. A lower membership fee applies.

Membership subscription fee payment

We value inclusivity and have a preference for involvement from all those who are interested. The sustainability of our network however depends on having funds to support the work of the secretariat. As the Qld government does not provide recurrent funding of networks within the DFV sector, funding for the secretariat is based on membership subscription fees, any proceeds from our annual professional development forum, and a recurring charitable grant through our partnership with Challenge DV, supported by a good dose of voluntary labour.

Fee structure

Annual membership subscription fees are based on the extent of funded program activity and are payable by 30th September each year. Fees currently are set as follows. Figures are **inclusive of GST**:

Full Membership

- For an organisation or branch (site): \$480
 - for organisations, or branches of larger organisations running only one group program, or conducting other related activities
 - e.g. for an organisation operating 2 branches, with one program running in each branch, the fee is \$960
- For an organisation running more than one concurrent group program at a specific branch, an additional \$165 for each additional concurrent group
 - e.g. for an organisation / branch running two concurrent group programs, the total fee is \$645
 - This is capped at \$810 for 3 or more programs
- Individual practitioner: \$85

Associate Membership

- For an organisation or branch (site): \$360
 - for organisations, or branches of larger organisations running only one group program, or conducting other related activities
 - e.g. for an organisation operating 2 branches, with one program running in each branch, the fee is \$720
- For an organisation running more than one concurrent group program, an additional \$130 for each additional concurrent group
 - e.g. for an organisation / branch running two concurrent group programs, the total fee is \$490
 - This is capped at \$620 for 3 or more programs
- Individual practitioner: \$65

Fee subscriptions are on a financial year basis (1 July to 30 June). Fees are halved for memberships commencing between December and April. Memberships commencing in May or June are current until the end of the following financial year.

The intention of this fee structure is that organisations running funded programs subscribe at the organisation rate. All nominated employees are then automatically treated as Employee Members. Use of Individual membership for employee practitioners is available only to those who are not part of organisations with perpetrator intervention program funding, or where an employee also wishes to join as an Individual member in their own right. The Associate membership categories have a lower fee to reflect the fact that they do not have voting rights.
